Muğla Olgunlasma Institute is an official public institution affiliated to the General Directorate of Lifelong Learning, established in the 2018-2019 academic year in Menteşe district of Muğla. The structuring of our institution is based on 4 basic units. These basic units are; Research, Design, Production and Promotion Marketing units and our institution fulfills all its activities with 14 different workshops. Our corporate mission is to preserve the elements of national culture and transfer them to future generations by researching cultural values. Our institute, which continues successfully on a national scale with 65 master instructors and 16 teachers, updates and archives traditional handicrafts, and promotes Turkish culture with projects/themes at national and international level. Aiming to protect

cultural heritage, our institute makes innovative production by providing quality service with our expert staff and transfers our cultural heritage to future generations.

Our institution has not been involved in any European Union project since its establishment. For this reason, it cannot fulfill its mission of transferring our cultural heritage to future generations through digital platforms. In addition, we aim to take part in projects within the Erasmus platform in cooperation with partners that overlap with our institution's mission, who can act jointly and with whom we can interact positively.

These projects are carried out in cooperation with the fabric weaving, carpet weaving, rug weaving, jewelry and jewelry making, ceramics, fashion design, embroidery, visual arts, decorative handicrafts and food and beverage workshops within the institute. After the projects are completed, innovative modernized products that transfer our cultural heritage to future generations are obtained.

Within our institution, 1 institute program and 2 official certified course programs are carried out.

#### Institute Program Being Conducted in Our Institution:

2-Year-Institute Program is implemented in the Fashion Design Technologies Area, Clothing Pattern Design and Production Workshop Branch. Students participating in this program will have a certificate of opening a workplace, a certificate of mastery and a vocational high school equivalence diploma.

#### Courses Being Conducted in Our Institution:

- 1. Women's Dress Sewing Course: It includes mold making, model application to the basic body molds, and practical training on sewing the dress to which the model is applied.
- 2. Leather Bag Making Course: It includes the practical training of making bags, wallets, card holders, belts and jewelry accessories from leather leather.

The branches and specialization areas of our 16 teachers working in our institution are different and the common need of all of these teachers is to improve their digital competencies. The Scientific Digital Competence Scale was used to determine this need and 90% of our 16 teachers had low digital competence. In order to increase this competence, the national Digitalization of Institutes project is being carried out in our institution.

For this reason, we aim to increase the quality of human resources of our institution through trainings and on-site observation methods to be carried out with organizations with high digital competence, open to innovative designs and organizations within the Erasmus platform. Thanks to this project, we believe that we will achieve these goals and increase our institutional capacity.

Within the framework of this mission, all of the education, production, course and institute activities in our institution consist of face-to-face and traditional learning methods. However, in order to transfer our cultural heritage to future generations and to open different innovative courses, our teachers and master trainers need to benefit from online learning environments, design innovative products supported by digital design and artificial intelligence, and archive all these cultural heritage works in digital environment. For this reason;

- -The need to classify the rich cultural collections in our institution according to classical and modern technologies, to create digital archives and to be included in world catalogs
- -The need to transform the digital archive to be created into an Inventory Digital Catalog to make it visible, known and accessible to a wider audience
- -The need to increase the digital competencies of our teachers working in our institution in order for all these digital activities to be successful
- There is a need to have the necessary technological hardware and software to carry out the relevant digital studies.

Within the scope of this project, trainings to be received from internationally approved and experienced training organizations and on-site observation method will ensure that the quality of our institution's human resources and our institutional production capacity reach the EU standards. Thanks to the digital archiving targeted within the scope of the project, cultural heritage will be transferred to future generations more. In addition, the training and experiences obtained through the project will be shared with other employees in our institution within the framework of a plan, ensuring both widespread impact and keeping the information obtained up to date. In addition, with this widespread impact, our teachers will start to use the Erasmus platform effectively and work in cooperation with teachers in other countries, improve their foreign language and digital skills, self-confidence and motivation, and contribute to their personal and professional development. In the end, the motivation of the teachers of our institution to learn and produce will increase, and they will gain the skills to better see their digital goals and develop solution strategies to overcome challenges.

In addition, our organization's corporate visibility on EU platforms, national and international sales and marketing strategies will be strengthened by achieving high digital competence standards.
